Further, refer to CGEWHO's letter of even reference dated 22/04/2016 seeking car parking option and subsequent letter dated 25/05/2016 inviting options for preferential allotment of ground floor DU/Flat to persons with disability (PwD) as per CGEWHO Rule-24.

2. On request of the PMC members and for convenience of large numbers of beneficiaries at Punjab, it is decided that draw of lots will be held at Mohali Project Office adopting manual method. The draw of lots for allotment specific flat/floor will be held at Mohali, by a Committee of Officers represented by an officer from M/o HUPA. The allotment committee may bring any changes in the draw procedure as stated, if required, at any point of time and authorized to take help of any member-beneficiary in attendance for conducting the draw in smooth, transparent and independent manner.

In view of the above, all beneficiaries are invited to be present as per the schedule mentioned above with their spouse along with Photo Identity Card and this Letter of Invitation with the envelope for security check and record attendance in order of their arrival to participate in the draw of lots. The detailed 'Draw Procedure' is enclosed for information.

4. 129 Car Parking out of 158 No(s) available have been allotted (List is available at CGEWHO's website). Allotment of specific Parking No(s) will be done at CGEWHO's Head Office, considering beneficiary's priority (established in the draw of lots) and location of block (of allotted flat) in order to keep the satisfaction and convenience level optimum for beneficiary. In case of beneficiary interested to get allotment of Car Parking he/she may apply along with a DD of Rs.2.50,000/- immediately as it is open on "First come First served" basis.
