MINUTES OF GENARAL BODY MEETING OF KENDRIYA VIHAR-II APARTMENT OWNERS' ASSOCIATION, HELD ON 21ST MARCH, 2016 (MONDAY) AT 5.00 PM AT COMMUNITY CENTRE, KENDRIYA VIHAR PASE-2, KOLKATA

At the outset, president welcomed all flat owners present in the meeting and greeted in advance for "Holi festival" all flat owners and their family members. He also informed that CGEWHO has written a letter to form formal AOA as they will leave the campus by 31st March, 2016.

Agenda No.: 1: Construction of Website

Resolution: The issue as per above Agenda was deliberated in the Meeting in details and it was unanimously decided that such a website is a must and launched immediately with proposed the domain name of

'www.kendriyaviharphase2kolkata.org'

Agenda No.: 2: Adoption of bye laws (draft)

Resolution: The final bye laws (draft) were uploaded in the official website of CGEWHO. It was, therefore, considered to have been read and understood by the General Body. A copy of the said bye laws was also provided to each member before the GBM for deliberation. The bye laws were discussed comprehensively and adopted by majority voting (i.e. 25 nos. in favor, and 7 nos. refrained from voting) with following suggestions.

- a) Day of Meeting: It was urged that GBM/AGMs should be held on Sundays and Holidays for convenience of the flat owners. This issue was discussed and it was decided unanimously to hold the GBM/AGM on Sundays and Holidays (exceptfestival days).
- b) Quorum for Meeting: It was pointed out that the quorum should not be 60 nos. as proposed in the bye laws (draft) and it should be 1/3rd of the total eligible members of the Association. This suggestion was discussed and accepted for inclusion in the bye laws unanimously.
- c) Re-convening of Meeting after Adjournment: Since most of the allottees are staying outside the complex, it was urged that in the event of non-fulfillment of quorum, the adjourned meeting should be re-convened on the same day and place after one hour of adjournment so as to facilitate maximum participation in the meeting. This was discussed threadbare and it was unanimously agreed that necessary provisions may be incorporated in the bye laws to this effect.
- d) Redefining common areas: It was argued that the allotted parking areas should not be shown as common areas as mentioned in the bye laws [Clause 2 g (iii)], though these should be maintained by the Association. This was deliberated and it was decided by majority that necessary clarificatorymodifications will be made in the bye laws accordingly.
- e) Inclusion the word Ad-hoc in "MEMBERS OF EXECUTIVE COMMITTEE" [P. 6 of the draft bye laws]: Since the existing committee is Ad-hoc committee, it was suggested by

some flat owners that "Ad-hoc" word should be included before EXECUTIVE COMMITTEE [P.6 of the draft bye laws]. It was readily agreed by the Chair.

f) Increase in the number of EC members from existing 15 to 20. This issue was extensively dwelt upon in the meeting. Out of the present 32 members only 12 members supported and hence it was dropped.

All these suggestions will be duly included in the bye laws and the same will be modified accordingly and the modified bye laws are treated as adopted with said modifications for the purpose of formation of AOA (regular) as per West Bengal Apartment Owners' Act, 1972.

Agenda No.: 3: Discontinuation of PIC, CGEWHO office after 31.03.2016: In the face of repeated insistence by the CGEWHO to discontinue after 31.03.2016, further course of action in this regard was elaborately discussed in the meeting and it was unanimously agreed that in continuation to President, AOA, Ad-hoc Executive Committee earlier letter dated 14.03.2016, another reminder should immediately be issued to CGEWHO for their continuance for another six months in the interest of the complex.

Agenda No.: 4:Other issues raised with the permission of the Chair:

i) ParikshitBasu, C4-101:

Q: Clarification was sought as to whether only members having registered their flats can take part in voting or otherwise.

A: All 582 members may be eligible for voting. However, legal opinion in this regard will be taken as it is required.

ii) P.K.Misra, B1-503:

Q: Raised the issue of immediate appointment of at least one Electrician, one additional plumber and one supervisor.

A: Clarified that complete office of the association with necessary furniture, equipment & manpower will be set up as per the acceptance by the majority, which will include appointments of two Electricians, two plumbers, four malis and one supervisor.

iii)SuvashishDutta, D9-409:

Q: Whether any date has been fixed for AOA election.

A: A date will be fixed after completion of WB assembly election, 2016 which will be intimated well in advance.

iv) Sumit Deb Barman, B5-101:

Q: How the rate of Rs 3,000/- has been fixed for booking of Community Centre.

A: Clarified that this rate was fixed by the Secretary and it can be reviewed after formation of AOA.

v) GoutamGanguly, B4-503:

Q: Construction of toilet and security hut at the second gate.

A: One additional toilet and security hut will be constructed by the CGEWHO, as has been agreed by them in writing.
