

# 1 Section I: Instructions to the Applicants

## 1.1 Definitions:

- i) **'General Body'** means the list of Members given under Para-6 of the Memorandum of Association.
- ii) **'Governing Council'** means the list of members given under Para-5 of the Memorandum of Association.
- iii) **'CGEWHO'** means the Central Government Employees Welfare Housing Organisation.
- iv) **'Scheme'** means the 'self-financed housing project' announced by the CGEWHO.
- v) **'Dwelling Unit' or 'DU'** means a single storey /duplex type/ flat/ apartment/ villa type of housing unit constructed in independent group housing or multistoried construction or marked plots.
- vi) **'Beneficiary'** means an eligible applicant whose booking for a dwelling unit has been confirmed by the CGEWHO. Beneficiary allotted with specific dwelling unit be called allottee as well.
- vii) **'Society/AoA'** : means Society or Association of Allottee(s) formed by the beneficiaries of any CGEWHO's Project named as 'Kendriya Vihar'.
- viii) **'Kendriya Vihar'** : Complex developed by CGEWHO in any station named as Kendriya Vihar followed by station name [like Kendriya Vihar, Chennai, Kendriya Vihar, Kolkata, Kendriya Vihar, Noida, Kendriya Vihar, Gurgaon etc.]
- ix) **'NOC or NDC'** : meant for No Objection Certificate or No Dues Certificate.
- x) **'Parking'** : Space in the basement or still or garage for the sole purpose of parking of two/four wheeler.
- xi) **SC / ST/ PwD** : stands for Scheduled Caste, Scheduled Tribe and Person with Disability.
- xii) **ITI Ltd.:** A service provider to develop and customize the software and facilitate the process of e-auctioning [[www.tenderwizard.com/CGEWHO](http://www.tenderwizard.com/CGEWHO)] on application service provider model. Successful H1 bidder will be required to pay @0.5% of bid value including GST within 7 days through online mode to M/s ITI Ltd.

## 1.2 Eligibility Criteria

- i) **Central Government Employees:** Serving or retired Central Government Employees, who are covered by the definition as given at Para 2(vii) of Part B of this Brochure, will be eligible.
- ii) **Spouses of deceased employees:** Spouses of the deceased Central Government Employees or deceased retired employees would be eligible, if the deceased employee would have qualified by criteria (i) above.
- iii) **Employees of CGEWHO,** with a minimum of one year of service, will be eligible.
- iv) Employees in service of Central PSUs, State Government, Union Territory Administration, Autonomous Bodies, Corporations, Nationalised Banks etc.
- v) Serving uniformed employees of the Ministry of Defence and serving employees of Ministry of Railways.
- (vi) Those are not covered under Priority-I and Priority-II including General Public.

### **GENERAL CONDITIONS :**

- i) The applicant and joint applicant must be citizen of India.
- ii) She/he should have attained the age of majority i.e. an applicant should have completed 18 years of age as on the date of submitting the application.
- iii) There is no income criterion. The applicants can apply according to their own requirement and affordability.
- iv) The first/sole applicants should have an account in any bank and particulars of the account must be given in application form and a cancelled cheque of particular account should be enclosed.
- v) Applicants must quote and enclose a copy of permanent account number (PAN) allotted under the provisions of Income Tax Act and the same must be quoted in the application form.
- vi) In case of joint application under SC/ST reserved category, the joint applicant should be within the family (i.e. Spouse & Dependants relation including unmarried children).
- vii) In case of joint application under deceased central government employees, persons with disabilities the applicant, himself or herself should fall within the categories and joint applicant should be from within the family. (i.e. Spouse & Dependants relation including unmarried children).
- viii) Allotments shall be made in the order of priority given below.

## 1.3 How to apply & Acceptance of Bid

- 1.3.1 Interested parties will need to register and obtain user ID and password on the portal and thereafter deposit non-refundable and nonadjustable E-Brochure document fees of INR 500/- and Processing Fees of INR 2,000/- separately against each property for participation in the e-auction through online payment on or before date as mentioned on the portal. CGEWHO will not be responsible for any payment after that and bid will not be considered.



- 1.3.2 It will be the sole responsibility of the bidder/participant to obtain a compatible computer terminal with internet connection to enable him/her to participate in e-bidding process any reasons thereof. Ensuring internet connectivity at the bidder's end shall be the sole responsibility of the bidder. Any request/complaint regarding the connectivity of internet at the bidder's end will not be entertained in any form and shall not be basis of cancellation of the bidding process.
- 1.3.3 Bidder is required to deposit a separate EMD for each advertised property.
- 1.3.4 The CGEWHO may without assigning any reason withdraw any or all the sites from the e-auction at any stage and is not bound to accept the highest bid or all bids even if they are above the reserve price.
- 1.3.5 CGEWHO reserves the right to accept or reject any or all the bids or cancel/postpone the e-auction without assigning any reason.
- 1.3.6 Bidding will not be permissible below the reserve price rate of the DU. The first bid price shall be sum of reserve price plus the first incremental amount.
- 1.3.7 If the bidding continues till the last 10 minutes of the scheduled/extended closing time of auction, in such case, the bidding time shall be automatically extended for further 10 minutes from the last Bid.
- 1.3.8 Post registration, e-bidder shall proceed for login by using his ID and password. Bidder shall proceed to select the event he is interested in. the e-bidder would have following options to make payment towards e-brochure fees, processing fees and EMD through valid:

- 1.3.9 Incomplete bid documents will not be considered.

- 1.3.11 The Pre-qualification Bids shall be opened by the Committee constituted by CGEWHO.
- 1.3.12 After verification of related documents upload by the highest Bidder/Applicant, allotment letter to the successful highest Bidder/Applicant will be issued by CGEWHO within 30 days of the closure of auction.

#### 1.9 Payment options & schedule

- 1.9.1 **Option 1:** 10 percent of Reserve price at the time of participation in the e-auction. The balance within 45 days from the date of issue of Allotment letter then rebate of 5% will be applicable.
- 1.9.2 **Option 2:** 10 percent of Reserve price at the time of participation in the e-auction. The balance within 120 days of from the date of issuance of Allotment Letter.
- 1.9.3 Other conditions:
- The Bidder has to give his option for the payment plan (**OPTION 1 OR OPTION 2**) along with the bid.




