**ADDITIONAL CHARGES:** - AOA charges @1.5% of the total price of the DUs shall be levied extra.

**Rebate:** - If the allottee pays the total cost of the DUs within 45 days from the date of booking, rebate @2.5% shall be allowed.

**Late/delay in payment of instalment:** - If the allottee pays the due instalment after the due date, interest @10% p.a. shall be levied for delayed period.

**Cancellation/withdrawal Charges:** - If the applicant does not pay the due amount of DUs within 90 days from the date of allotment, the booking amount is liable to be forfeited.

**Maintenance Charges of Society:** - The maintenance charges of the society shall be levied & collected by the Apartment Owners Association (AOA) in line with their charges & bye-laws and the same will be paid to the AOA after the physical possession of the DUs.
