Cost of DU given above is exclusive of GST (as applicable), 1% for IFMS & 1% for advance maintenance charges for one year. However, the cost of one covered car parking (stilt or basement) is included in the cost of DU.

- 3. Since the cost and the configuration have been revised and accordingly, the following options are being offered. You are requested to go through the following options and give your consent for any one of the options as per the **Annexure-I** attached herewith.
  - a. Withdrawal from SAS Nagar Housing Scheme: All Type 'A', 'B' 'C' & 'D' applicants can withdraw their application from the scheme. Their deposited amount shall be refunded with interest @ 5% per annum from 31.07.2014 (i.e the last date of the scheme) or date of receipt of amount in CGEWHO's account, whichever is later, till the last date of submission of the option as per Annexure-I, i.e by 17.09.2024.
  - b. <u>Type 'A' Applicant</u>: Since there is no Type 'A' DUs in the revised plan, Type 'A' applicants have the option to migrate ONLY in Type 'B' dwelling unit.
  - **c.** <u>Type 'B' Applicant</u>: Type 'B' applicants have the option to either remain in Type 'B' or withdraw from the scheme.
  - **d.** Type 'C' Applicant: Type 'C' applicants have the option to either remain in Type 'C' or to migrate in the lower category, i.e to Type 'B'.
  - e. <u>Type 'D' Applicant</u>: Type 'D' applicants have the option to either remain in Type 'D' or to migrate in the lower category, i.e to Type 'C' or Type 'B'.
- 4. The applicants who will give consent to either remain in the same type or migrate will be given confirm allotment, with revised cost and configuration, along with interest @ 5% per annum from 31.07.2014 (i.e the last date of the scheme) or date of receipt of amount in CGEWHO's account, whichever is later, till the last date of the revised scheme. However, the adjustment of the above interest will be given at the time of calling of last and final instalment. (Please refer to Option-II (b) of the letter no.A-110/6 (Vol-II) dated 31.01.2017).
- 5. Please be informed that the last date for receiving the option in **Annexure I** is **17.09.2024**.
- 6. If the option is not received latest by 17.09.2024, it will be presumed that applicant is not interested to continue in the scheme, and accordingly his refund will be processed.
