Once the complaint received, the Chairman of the Committee will make preliminary inquiry on the issue and if the Chairman feels any gravity in the issue, then will call meeting of all the members and will do complete inquiry related to the complaint so received and take necessary action with the consent of all the members of the Committee.

It is also directed the Chairman of the Committee that she will regularly conduct the orientation programme to upskill members of the Committee and to educate womeemployees about provisions of the Act, Rules and Regulations.

### Point (iii) of Para 3

As required vide Office Memorandum dated 28th November, 2023, CGEWHO commemorated the week running upto 9th December, 2023 vide Office Order No. 315 dated 4th December, 2023, by at the Workplace. (copy enclosed as holding the session on Prevention of Sexual Harassment created about the Sexual Harassment Act 2013 Annexure II). In this session, awareness was CGEWHO. Also discussed all ways and means to prevent sexual among the working women in harassment of women employees.
