2) Advocate Fees: The Agreed Fees quoted by the above Advocates for providing the complete services for the smooth Execution of "Conveyance Deed" (including preparation of documents, etc.) are Rs. 5,000/-per dwelling unit.

Please note that;

- i) The "Conveyance Deed" is required to be registered/executed before the concerned office of the sub-registrar in Avadi, Chennai. The charges of registration fee, stamp duty, computer fees, CD Fees, documents charges, Patta Sub-division charges (If applicable), scanning fees, and/or any other charges, including miscellaneous, etc., are to be paid by the allottees in addition to the advocate fees.
- ii) After the execution of "Conveyance Deed", the advocate will have to submit the original copy along with a photocopy at CGEWHO HQ through the CGEWHO site official for office record for further handover to the allottees/banker. Further, a photocopy of the "Conveyance Deed" is also required to be provided to the allottee/beneficiary.
- 3) The general steps/process for execution of the "Conveyance Deed" includes:
 - i) Payment of cost of stamp paper to Tamil Nadu State Govt. Treasury as per the advice of the advocate.
 - ii) Collection of e-stamp paper from the respective stamp vendor, Preparation and printing of "Conveyance Deed" in the prescribed format, duly approved by the CGEWHO.
 - iii) Getting it signed by the beneficiary & its co-owner(s) and CGEWHO's authorised official with proper coordination over the telephone.
 - iv) Presenting it before Sub-Registrar Avadi, Chennai, Tamil Nadu office at the appointed date for registration, after completing the KYA [Know Your Allottee] process.
 - v) Thereafter, the document(s) will be submitted before the Sub-Registrar Office for registration with prior online appointment of the Sub-Registrar Office at Avadi, Chennai, Tamil Nadu.
- 4) Please note that there is no binding on any beneficiaries to take the services from the above-mentioned empanelled advocates. The CGEWHO has done the empanelment of the above advocates to facilitate the beneficiaries for the smooth execution of the "Conveyance Deed". Further beneficiaries are also free to take services from any other advocate of their choice to get registered the "Conveyance Deed" with the office of the sub-register in the CGEWHO prescribed format of "Conveyance Deed".
